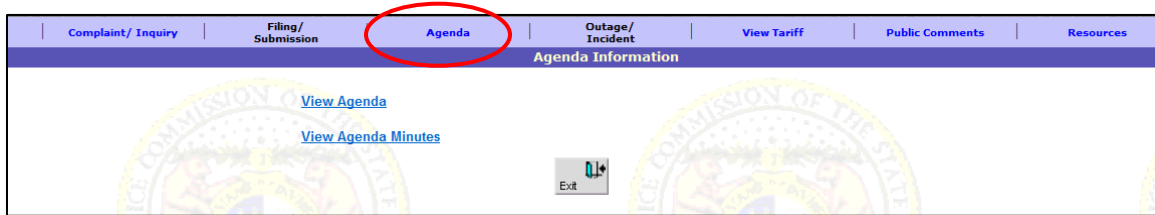

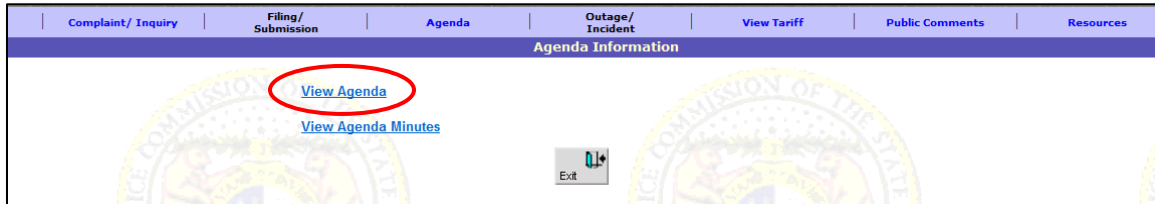

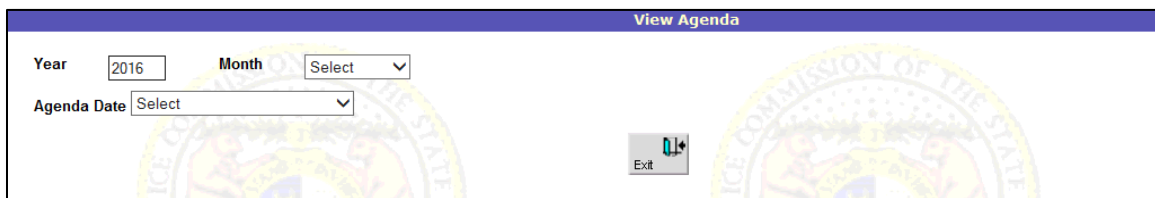

The Official Agenda of the Commission is posted on the 3rd Floor of the Governor Office Building in the vicinity of the receptionist's area and may include additional items.

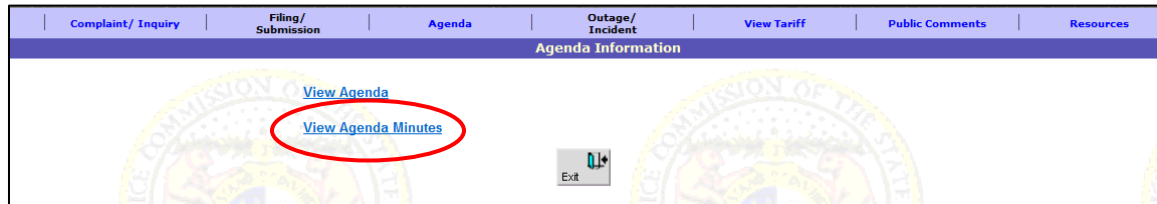

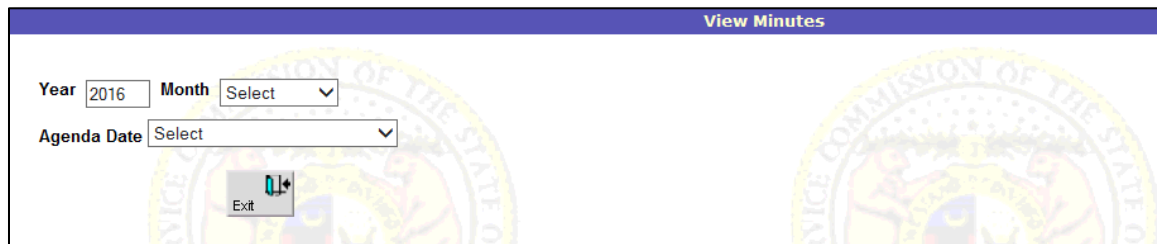
